What is the Derbyshire Community Health Services (DCHS) Charitable Trust?

The DCHS Charitable Trust is a registered charity with the Charity
Commission (Charity number 1053329).

The DCHS Charitable Trust holds funds for hospital locations across
the county, as well as other community services, such as district
nursing and health visitors.

The Trust holds its own bank account and it is completely separate
from any of the DCHS NHS Foundation Trust bank accounts.

What are charitable funds?

Often, people like to express their appreciation for the help and care they have received, by making a donation to the DCHS Charitable Trust.

What will the donation be used for?

Charitable funds can be used to provide equipment and services to improve the quality of care of patients that would not normally be provided through NHS funding.

We would prefer that you gave your donation to be spent generally within our services. This would enable the money to be spent where it was needed the most. We could also use the money donated towards services including community and specialised nursing. Any

donations are always gratefully received.

How can you make a donation?

If you would like to make a donation, there are several ways you can do this:

- You can use the donation form overleaf and return it with a signed cheque
- Some people make standing orders or direct debits from their bank accounts to our charitable funds

Increase your donation for FREE - *giftaid it*

The tax office can increase your donation if you pay income tax.

This means we can reclaim the tax without any cost to you by ticking the Gift Aid box.

Our Charity can reclaim the tax on all donations through the Gift Aid Scheme with no added cost to the person making the donation. Currently we can claim 25p in every £1 - that's a further £2.50 on every £10 given.

How will you know if your money has been spent?

All charitable donations received and subsequently spent have to be accounted for. These are summarised in the Annual Report and Accounts of the Charity, which are submitted to the Charity Commission.
