## Latest developments

Pharmacy-led sites in Derby, Hatton and Horsley Woodhouse will begin vaccinations on Friday, adding an extra dimension to the COVID-19 vaccination programme. The new sites will be able to book patients through the National Booking System, thus providing new options for eligible patients.

All three sites are in community venues, not in the pharmacies themselves, and people still require appointments before they can receive a vaccination.

The public continue to show amazing support for the staff and volunteers at vaccination sites, with great feedback and steady flow of donations and gifts.

Staff at the Oaklands vaccination site were treated to food deliveries from Morrisons, and The Garden King donated a load of rock salt. Ice and Slice pizza parlour also brought pizza on a Saturday for all staff and volunteers.

Derby Arena staff and volunteers received a huge delivery of doughnuts from Project D.

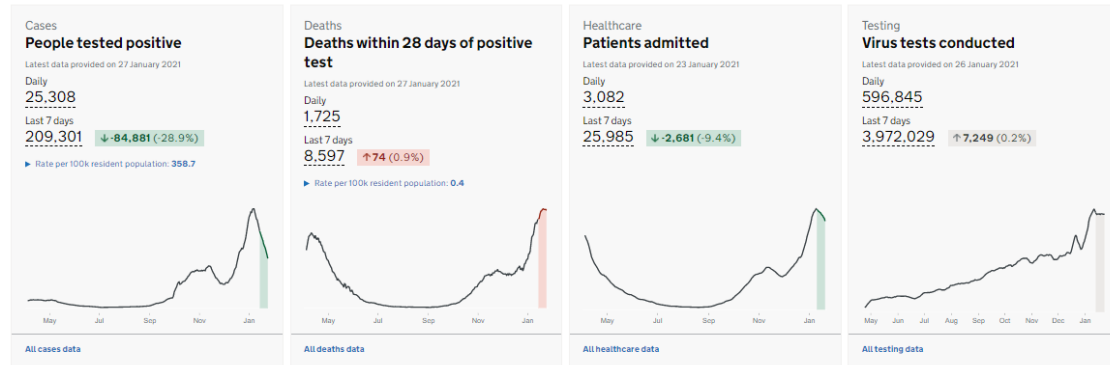

## FAQs

Which frontline health and social care staff currently qualify for a COVID-19 vaccine?

- staff working on the vaccination programme
- staff who have frequent face-to-face contact with patients and who are directly involved in patient care in either secondary or primary care, mental health, urgent and emergency care and community settings
- those working in independent, voluntary and non-standard healthcare settings such as hospices, and community-based mental health or addiction services
- laboratory, pathology and mortuary staff
- those working for a sub-contracted provider of facilities services such as portering or cleaning
- temporary, locum or 'bank' staff, including those working in the COVID-19 vaccination programme, students, trainees and volunteers who are working with patients
- frontline social care workers directly working with vulnerable people who need care and support irrespective of where they work (e.g.: in hospital, people's own homes, day centres, or supported housing); or by whom they are employed (e.g.: local government, NHS, independent sector or third sector).

## Next steps

Derbyshire now has 15 PCN-led sites, three pharmacy-led sites, a mass vaccination centre and two hospital hubs, but the work is not finished yet. Four more pharmacy-led sites are being checked and prepared, and two more smaller hospital hubs may also come online.
